UNDER THE PROVISIONS OF SECTION 9, CHAPTER 78, NEW HAMPSHIRE REVISED STATUTES 1977, AS AMENDED, KNOW ALL MEN BY THESE PRESENT, THAT WE, _____ OF _____, AS PRINCIPAL, AND _____ OF _____, AS SURETY, ARE HELD AND FIRMLY BOUND UNTO THE COMMISSIONER OF REVENUE ADMINISTRATION, (HEREINAFTER CALLED THE COMMISSIONER) AND HIS SUCCESSOR IN OFFICE, IN THE SUM OF \$ _____, FOR THE PAYMENT OF WHICH, WELL AND TRULY TO BE MADE, WE BIND OURSELVES, OUR HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS, FIRMLY BY THESE PRESENT, BUT THE CONDITION OF THIS OBLIGATION, IS SUCH THAT WHEREAS, THE PRINCIPAL IS A LICENSED DISTRIBUTOR OF CIGARETTES AS CONTEMPLATED BY THE PROVISIONS OF CHAPTER 78 OF THE NEW HAMPSHIRE REVISED STATUTES 1977, AS AMENDED, AND WHEREAS UNDER THE PROVISIONS OF SECTION 7, CHAPTER 78, NEW HAMPSHIRE REVISED STATUTES 1977, AS AMENDED, A TAX IS IMPOSED ON THE SALE OF ALL CIGARETTES SOLD IN NEW HAMPSHIRE, TO BE EVIDENCED BY THE AFFIXING OF STAMPS OR OTHER INDICIA APPROVED BY THE COMMISSIONER TO THE PACKAGES CONTAINING SUCH CIGARETTES AND WHEREAS, UNDER THE PROVISIONS OF SECTION 9 OF SAID CHAPTER, AS AMENDED, THE COMMISSIONER MAY SELL SUCH STAMPS AND INDICIA TO THE PRINCIPAL AND PERMIT THE PRINCIPAL TO PAY THEREFOR WITHIN THIRTY (30) DAYS AFTER THE DATE OF PURCHASE, PROVIDED A BOND SATISFACTORY TO THE COMMISSIONER CONDITIONED FOR THE PAYMENT OF SUCH PURCHASE IS FILED. NOW, THEREFORE, IF SAID PRINCIPAL SHALL PAY FOR ALL SUCH STAMPS AND INDICIA PURCHASED BY SAID PRINCIPAL FROM THE COMMISSIONER WITHIN THIRTY (30) DAYS AFTER THE DATE OF PURCHASE THEREOF, THEN THIS OBLIGATION SHALL BE NULL AND VOID, OTHERWISE TO BE AND REMAIN IN FULL FORCE AND EFFECT. THE TERM OF THE BOND SHALL BE FOR ONE YEAR FROM THE _____ DAY OF _____, 20_____.
