ITEM # 3 Operation Number	Number stamped by the Department of Revenue Administration in the upper right hand corner of the Report of Cut Form (PA-8).
ITEM # 4 Species	Species reported cut under Line # 8 of the Report of Cut Form (PA-8).
ITEM # 5 Number of MBF, Tons or Cords	Volume reported by the Operator under Line #8 of the Report of Cut Form (PA-8).
ITEM # 6 MBF, Tons or Cords	Check the type of measurement used.
